IN THE MATTER OF:  
SPECIAL PROJECTS COURT COSTS

This is a supplemental order in accordance with Ohio Revised Code Section 1907, regarding the collection of court costs to be deposited into the Special Projects Fund.

Effective January 1, 2022, court costs on all criminal and all traffic cases will increase by Twenty-Five Dollars (\$25.00). The additional amount shall be deposited into the Municipal Court Special Projects Fund. The total court cost amount for all criminal and all traffic cases will be Ninety-Five Dollars (\$95.00).

Effective January 1, 2022, the filing fee for an Amended Complaint will increase by Fifty Dollars (\$50.00). The additional amount shall be applied according to the breakdown of court costs for a Complaint for Judgment. The total cost for filing an amended complaint will be One Hundred Dollars (\$100.00).

Effective January 1, 2022, the filing fee for Small Claims cases will increase by Seventeen Dollars (\$17.00). The additional amount shall be deposited as follows: Additional Twelve Dollars (\$12.00) into the County General Local Costs and Five Dollars (\$5.00) into the Municipal Court Special Projects Fund. The total cost for filing a small claims case will be Sixty Dollars (\$60.00).

Effective January 1, 2022, the filing fee for a Wage Attachment will increase by Twenty Dollars (\$20.00). The additional amount shall be deposited into the Municipal Court Special Projects Fund. The total cost for filing a Wage Attachment will be Ninety Dollars (\$90.00).


Effective January 1, 2022, the filing fee for a Bank Attachment will increase by Twenty Dollars (\$20.00). The additional amount shall be deposited into the Municipal Court Special Projects Fund. The total cost for filing a Bank Attachment will be Fifty-Nine Dollars (\$59.00).

Effective January 1, 2022, the court cost for a Request for Certificate of Judgment Lien will increase by Ten Dollars (\$10.00). The additional amount shall be deposited into the Municipal Court Special Projects Fund. The total cost for filing a Request for Certificate of Judgment Lien will be Twenty-Five Dollars (\$25.00).

Effective January 1, 2022, the court cost to reissue by certified mail on any case will increase by Eighteen Dollars (\$18.00). The additional amount shall be deposited into the County General Local Costs. The total cost to reissue by certified mail is Twenty-Five Dollars (\$25.00).

The previous order for disbursement of funds from the Special Projects Fund to the Carroll County Victim Assistance Funds remains the same.
